


Business Description

Euroconsult Engineering Consulting Group SA is a civil engineering and construction engineering consulting providers in the Spanish market. The company serves public and private clients to plan, design, build, operate and maintain projects. Its activities are divided into three markets including Transport infrastructures, Architecture and urban engineering and Energy, water and environment. The company provides engineering services to clients in numerous countries, including France, Germany, Poland, Mexico, Brazil or the Dominican Republic. Services offered by Euroconsult include geotechnical engineering, pavement management, structural monitoring, among others. Its main clients are governments, multinational construction companies, concessionaire companies and multilateral organizations.

Valuation [°]as of 15 May 2024

Morningstar maintains a 3-star quantitative star rating for Euroconsult Eng Consult, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 1.60, below our quantitative fair value estimate of 1.69. These shares have traded between a 20.38% discount and 2.29% premium to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 82nd percentile; in the industrials sector, the firm's score lies at the 73rd percentile (meaning the shares are more undervalued than 73% of stocks in the sector).

Furthermore, Euroconsult Eng Consult maintains a quantitative valuation uncertainty rating of Extreme.

The company has held this star rating over the past year. The uncertainty rating for Euroconsult Eng Consult has remained Extreme since the previous rating of Very High, which was last assigned on 09/ 07/2023.

The key factors behind these ratings are the company's earnings yield and drawdown. The earnings yield is 6.53%, and its maximum trailing 12-month maximum drawdown is 0.00%. The earnings yield falls at the 71st percentile in the industrials sector while the drawdown is at the 5th percentile. Over the past year, the company's earnings yield has been between -1.89% and 6.99%; its drawdown has ranged between 0.00% and 0.00%.

Economic Moat [°]as of 15 May 2024

Morningstar maintains a Narrow quantitative moat rating on the company. The firm's quantitative moat score of 0.97 sits at the 89th percentile in the industrials sector. This is a decrease from 0.98, the maximum of its moat scores over the past year.

The quantitative financial health rating for Euroconsult Eng Consult is Strong. Its financial health score, termed Distance to Default, sits at the 85th percentile in the universe and 87th percentile in the sector.

The significant drivers of these ratings are the company's earnings yield and annualized trailing 12month volatility. The earnings yield for Euroconsult Eng Consult is 6.53%, and its annualized trailing 12-month volatility is 0.00%. They sit at the 74th and 5th percentile in the global equity universe, respectively.

Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analystdriven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. i. **Quantitative Fair Value Estimate:** Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None – assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iii. **Quantitative Star Rating:** Intended to be the summary rating based on the combination of our Quantitative Fair Value Estimate, current market price, Quantitative Uncertainty Rating, and momentum. The rating is expressed as One-Star, Two-Star, Three-Star, Four-Star, and Five-Star.

After the initial calculation for the star rating, there is a final filtering step based on the momentum of the company. We rank the companies based on their 12-1 month momentum, then restrict those below the 30th percentile to a maximum of 3 stars.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10% Medium – the interquartile range for possible fair values is less than 15% but greater than 10%

High – the interquartile range for possible fair values is less than 35% but greater than 15%

 $Very\ High\ -$ the interquartile range for possible fair values is less than 80% but greater than 35%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak – assigned when Quantitative Financial Health < 0.2

Strong - assigned when Quantitative Financial Health > 0.7

i. Last Close – Price of the stock as of the close of the market of the last trading day before date of the report.

ii. **Quantitative Valuation**– Using the below terms, intended to denote the relationship between the security's **Last Price** and Morningstar's quantitative fair value estimate for that security.

Undervalued – Last Price is below Morningstar's quantitative fair value estimate.

Farily Valued – Last Price is in line with Morningstar's quantitative fair value estimate.
