



#### **Business Description**

Plasticos Compuestos SA is engaged in n designing, producing, and selling mineral concentrates (fillers) and color and additive concentrates (masterbatches) for the plastic processing industry. The product portfolio includes color masterbatches, black masterbatches, white masterbatches, additives, compostable resins, and mineral concentrates.

### Valuation as of 16 May 2024

Plasticos Compuestos achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 1.79, above the previous closing price of 1.07. The stock has been trading between a 61.28% and 21.5% discount to its quantitative fair value over the past year. The stock's current valuation rating sits at the 18th percentile in the coverage universe and 40th percentile in the basic materials sector (higher percentile indicates more undervalued).

The quantitative uncertainty rating for Plasticos Compuestos is Extreme.

Our quantitative star rating remains unchanged over the past year; the uncertainty rating last differed on 10/25/2023, when it was Very High.

The main drivers of the company's valuation and uncertainty are its EV-MV ratio and volume. The enterprise value-to-market value ratio of 1.68 falls at the 82nd percentile in the equity universe and the 89th percentile in its sector. The trailing 12-month average volume (primary share) of 84 shares corresponds to the 5th percentile overall and the 5th percentile in the industry.

Economic Moat <sup>Q</sup> as of 16 May 2024

Quantitatively, we believe Plasticos Compuestos

has a Narrow economic moat. Its moat score of 0.73 corresponds to the 83rd percentile in the basic materials sector. Furthermore, this rating last differed from its previous rating of None on 05/13/2024, when the company's moat score fell from its maximum of 0.93 (score of 1 indicates greatest economic moat).

The company also maintains a quantitative financial health rating of Moderate. Its score sits at the 13th percentile overall and the 12th percentile in the sector.

Examining the company's financials and market statistics, we find these ratings are principally driven by its enterprise value-to-market value ratio and annualized trailing 12-month volatility. The enterprise value-to-market value ratio is 1.68, sitting at the 89th percentile in the basic materials sector. The company's annualized trailing 12-month volatility is 42.62%, corresponding to the 66th percentile in the equity coverage universe and the 45th percentile in the sector.





## **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. ### **Quantitative Equity Ratings**

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. - i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
