



Business Description

Commcenter SA is a national distributor of telecommunications service. It offers the widest range of voice and data solutions for companies, professionals and individuals. Services offered by the company include fixed connectivity, mobile connectivity and value-added services. Products offered by the company include Movistar +, Fusion+ and Fiber.

Valuation as of 17 May 2024

Commcenter achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 2.24, above the previous closing price of 2.10. The stock has been trading between a 40.73% discount and 0.23% premium to its quantitative fair value over the past year. The stock's current valuation rating sits at the 81st percentile in the coverage universe and 84th percentile in the communication services sector (higher percentile indicates more undervalued).

The quantitative uncertainty rating for Commcenter is Very High.

Our quantitative star rating remains unchanged over the past year; the uncertainty rating last differed on 03/27/2024, when it was Extreme.

The main drivers of the company's valuation and uncertainty are its EV-MV ratio and earnings yield. The enterprise value-to-market value ratio of 1.54 falls at the 79th percentile in the equity universe and the 76th percentile in its sector. The earnings yield of -1.71% corresponds to the 33rd percentile overall and the 36th percentile in the industry.

Economic Moat ^Q as of 17 May 2024

With a Narrow Morningstar quantitative moat rat-

ing, the quantitative moat score for Commcenter falls at the 86th percentile in the communication services sector and at the 88th in the equity coverage universe. The company has maintained its Narrow quantitative moat rating for the last year.

We also assign a Moderate quantitative financial health rating to Commcenter. The company's raw score on this metric, termed Distance to Default, ranks at the 71st percentile overall and 70th in the communication services sector. Furthermore, this financial health rating most recently changed from Strong after 04/02/2024.

Supporting these ratings are the company's enterprise value-to-market value ratio and enterprise value-to-market value ratio. The enterprise value-to-market value ratio of 1.54, ranks at the 79th percentile in the covered equity universe and at the 76th percentile among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.54, falls at the 79th percentile in the universe and the 76th percentile in the communication services sector.





Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
