



Business Description

Euroconsult Engineering Consulting Group SA is a civil engineering and construction engineering consulting providers in the Spanish market. The company serves public and private clients to plan, design, build, operate and maintain projects. Its activities are divided into three markets including Transport infrastructures, Architecture and urban engineering and Energy, water and environment. The company provides engineering services to clients in numerous countries, including France, Germany, Poland, Mexico, Brazil or the Dominican Republic. Services offered by Euroconsult include geotechnical engineering, pavement management, structural monitoring, among others. Its main clients are governments, multinational construction companies, concessionaire companies and multilateral organizations.

Valuation ^Qas of 3 May 2024

Morningstar affirms a 3-star quantitative rating for Euroconsult Eng Consult. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 1.60, a discount of 7.2% to its Quantitative Fair Value estimate of 1.72. The stock has been trading between a 20.38% discount and 4.33% premium to its quantitative fair value over the past year. The stock's price to fair value ratio is at the 82nd percentile in our global equity coverage universe for this methodology and at the 73rd percentile relative to its peers in the industrials sector.

Euroconsult Eng Consult furthermore holds a Extreme quantitative uncertainty rating.

The company's quantitative star rating remains unchanged over the past year. The firm's uncertainty rating changed from Very High to Extreme after 09/07/2023.

We examine the financials and market statistics for Euroconsult Eng Consult to determine these ratings. Its earnings yield is 6.56% and its trailing 12-month maximum drawdown is 0.00%. These fall at the 74th and 5th percentiles in the equity universe and at the 70th and 5th in the industrials sector, respectively.

Economic Moat ^Qas of 3 May 2024

With a Narrow Morningstar quantitative moat rating, the quantitative moat score for Euroconsult Eng Consult falls at the 87th percentile in the industrials sector and at the 90th in the equity coverage universe. The company has maintained its Narrow quantitative moat rating for the last year.

We also assign a Strong quantitative financial health rating to Euroconsult Eng Consult. The company's raw score on this metric, termed Distance to Default, ranks at the 75th percentile overall and 76th in the industrials sector. Furthermore, this financial health rating most recently changed from Moderate after 04/02/2024.

Supporting these ratings are the company's earnings yield and enterprise value-to-market value ratio. The earnings yield of 6.56%, ranks at the 74th percentile in the covered equity universe and at the 70th percentile among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.41, falls at the 75th percentile in the universe and the 74th percentile in the industrials sector.





Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.
