



Business Description

NBI Bearings Europe SA is engaged in designing and production of bearings. Its product offerings include cylindrical roller bearings, tapered roller bearings, spherical roller bearings, needle roller bearings, support rollers, cam followers, cylindrical roller thrust bearings, spherical roller thrust bearings and ball bearings. The company also provides technical services, bearing selection, training and tailor made solutions.

Valuation as of 30 Nov 2024

NBI Bearings Europe achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 4.86, above the previous closing price of 4.00. The stock has been trading between a 28.29% and 5.51% discount to its quantitative fair value over the past year. The stock's current valuation rating sits at the 59th percentile in the coverage universe and 52nd percentile in the industrials sector.

The quantitative uncertainty rating for NBI Bearings Europe is Very High.

Our quantitative star rating last differed from the current rating on 12/01/2023; the uncertainty rating last differed on 07/24/2024. The previous ratings were 4 and High, respectively.

The main drivers of the company's valuation and uncertainty are its EV-MV ratio and earnings yield. The enterprise value-to-market value ratio of 1.72 falls at the 82nd percentile in the equity universe and the 82nd percentile in its sector. The earnings yield of 4.41% corresponds to the 62nd percentile overall and the 56th percentile in the industry.

With a Narrow Morningstar quantitative moat rat-

ing, the quantitative moat score for NBI Bearings Europe falls at the 70th percentile in the industrials sector and at the 78th in the equity coverage universe. The company has maintained its Narrow quantitative moat rating since after 04/01/2024, when it was upgraded from None.

We also assign a Moderate quantitative financial health rating to NBI Bearings Europe. The company's raw score on this metric, termed Distance to Default, ranks at the 61st percentile overall and 62nd in the industrials sector. Furthermore, this financial health rating has stayed Moderate over the last year.

Supporting these ratings are the company's enterprise value-to-market value ratio and enterprise value-to-market value ratio. The enterprise value-to-market value ratio of 1.72, ranks at the 82nd percentile overall and among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.72, falls at the 82nd percentile in both the universe and the industrials sector.

NBI Bearings Europe reports earnings per share of 0.18. Its return on invested capital is 4.58%. These values are calculated over a trailing 12-month period

As of last market close, NBI Bearings Europe has a price-to-earnings ratio of 22.67, falling at the 58th percentile in its sector (where a lower percentile means a lower ratio) and ranging between 22.67 and 95.24 over the past year.



Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
