


Business Description

CLERHP Estructuras SA is a construction company. The company builds high rise buildings, shopping malls, offices, hotels, homes, and government buildings. It operates in Spain and South America. It also offers the service of expertise of structures, rental service of equipment and machinery related to the construction sector. CLERHP provides its services internationally, currently has a presence in Spain, Bolivia, Brazil and Paraguay.

Valuation ^Qas of 8 May 2024

Morningstar affirms a 3-star quantitative rating for CLERHP Estructuras. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 3.94, a premium of 6.52% to its Quantitative Fair Value estimate of 3.70. The stock has been trading between a 32.3% discount and 8.75% premium to its quantitative fair value over the past year. The stock's price to fair value ratio is at the 94th percentile in our global equity coverage universe for this methodology and at the 91st percentile relative to its peers in the industrials sector.

CLERHP Estructuras furthermore holds a Very High quantitative uncertainty rating.

The company's quantitative star rating remains unchanged over the past year. The firm's uncertainty rating changed from Extreme to Very High after 05/ 15/2023.

We examine the financials and market statistics for CLERHP Estructuras to determine these ratings. Its book value yield is 11.10% and its trailing 12-month maximum drawdown is 26.80%. These fall at the 13th and 45th percentiles in the equity universe and at the 10th and 52nd in the industrials sector, respectively.

Economic Moat ^Qas of 8 May 2024

With a Morningstar quantitative moat rating of None, the quantitative moat score for CLERHP Estructuras falls at the 51st percentile in the industrials sector and at the 58th in the equity coverage universe. The company has maintained its None quantitative moat rating since after 04/12/2024, when it was downgraded from Narrow.

We also assign a Moderate quantitative financial health rating to CLERHP Estructuras. The company's raw score on this metric, termed Distance to Default, ranks at the 35th percentile overall and 34th in the industrials sector. Furthermore, this financial health rating has stayed Moderate over the last year.

Supporting these ratings are the company's enterprise value and enterprise value-to-market value ratio. The enterprise value of 54.13 million, ranks at the 32nd percentile in the covered equity universe and at the 22nd percentile among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.09, falls at the 55th percentile in the universe and the 48th percentile in the industrials sector.

Fundamentals as of 8 May 2024

CLERHP Estructuras maintains earnings per share of 0.09. The company further earns a return on invested capital of 10.56%. These values are calculated over a trailing 12-month period.



Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

i. **Quantitative Fair Value Estimate:** Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None – assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

After the initial calculation for the star rating, there is a final filtering step based on the momentum of the company. We rank the companies based on their 12-1 month momentum, then restrict those below the 30th percentile to a maximum of 3 stars.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10% Medium – the interquartile range for possible fair values is less than 15% but greater than 10%

High – the interquartile range for possible fair values is less than 35% but greater than 15%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak – assigned when Quantitative Financial Health < 0.2

Strong - assigned when Quantitative Financial Health > 0.7

i. Last Close – Price of the stock as of the close of the market of the last trading day before date of the report.

ii. **Quantitative Valuation**– Using the below terms, intended to denote the relationship between the security's **Last Price** and Morningstar's quantitative fair value estimate for that security.

Undervalued – Last Price is below Morningstar's quantitative fair value estimate.
