



#### **Business Description**

Pangaea Oncology SA is a medical services company. The company provides a wide range of services to cancer patients, as well as global pharmaceutical and biotech clients, in the fields of molecular diagnostics, clinical trials, in vitro drug profiling, dx platform validation, and biomarker discovery. The company has aggregated its operations into two segments, Clinical Care division and Diagnostic and Research and Development services division. Clinical Care division delivers medical oncology services and related activities. Diagnostic and Research and Development services division provides diagnostic and in-vitro services.

### Valuation <sup>Q</sup>as of 8 May 2024

Morningstar affirms a 3-star quantitative rating for Pangaea Oncology. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 1.47, a discount of 9.6% to its Quantitative Fair Value estimate of 1.63. This discount has ranged between 35.64% and 0.17% over the past year. The stock's price to fair value ratio is at the 76th percentile in our global equity coverage universe for this methodology and at the 82nd percentile relative to its peers in the healthcare sector.

Pangaea Oncology furthermore holds a Extreme quantitative uncertainty rating.

The company's quantitative star rating remains unchanged over the past year. The firm's uncertainty rating changed from Very High to Extreme after 03/28/2024

We examine the financials and market statistics for Pangaea Oncology to determine these ratings. Its trailing 12-month maximum drawdown is 0.00% and falls at the 5th percentile in the equity universe and at the 5th percentile in the healthcare

sector.

### Economic Moat as of 8 May 2024

With a Narrow Morningstar quantitative moat rating, the quantitative moat score for Pangaea Oncology falls at the 90th percentile in both the healthcare sector and equity coverage universe. The company has maintained its Narrow quantitative moat rating for the last year.

We also assign a Strong quantitative financial health rating to Pangaea Oncology. The company's raw score on this metric, termed Distance to Default, ranks at the 95th percentile overall and in the healthcare sector. Furthermore, this financial health rating has stayed Strong over the last year. Supporting these ratings are the company's sales yield and annualized trailing 12-month volatility. The sales yield of 9.85%, ranks at the 17th percentile in the covered equity universe and at the 32nd percentile among its peers. Meanwhile, its annualized trailing 12-month volatility of 0.00%, falls at the 5th percentile in both the universe and the healthcare sector.

### Fundamentals as of 8 May 2024

Pangaea Oncology maintains losses per share of -0.09. The company further earns a return on invested capital of -10.66%. These values are calculated over a trailing 12-month period.





# **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. ## **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

**Very High** – the interquartile range for possible fair values is less than 80% but greater than 35%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
