



#### **Business Description**

Domo Activos SA operates as a real estate investment trust. It focuses its investments on residential properties.

### Valuation as of 30 Nov 2024

Domo Activos achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 1.89, above the previous closing price of 1.28. The stock has been trading between a 42.7% discount and 15.16% premium to its quantitative fair value over the past year. The stock's current valuation rating sits at the 32nd percentile in the coverage universe and 23rd percentile in the real estate sector.

The quantitative uncertainty rating for Domo Activos is Very High.

Our quantitative star rating remains unchanged over the past year; the uncertainty rating last differed on 11/28/2024, when it was Extreme.

The main drivers of the company's valuation and uncertainty are its earnings yield and drawdown. The earnings yield of 31.57% falls at the 95th percentile in the equity universe and the 95th percentile in its sector. The trailing 12-month maximum drawdown of 19.61% corresponds to the 28th percentile overall and the 48th percentile in the industry.

## Economic Moat <sup>Q</sup> as of 29 Nov 2024

Quantitatively, we do not believe Domo Activos has an economic moat. Its moat score of 0.55 corresponds to the 70th percentile in the real estate sector. Furthermore, this rating last differed from its previous rating of Narrow on 10/07/2024, when the company's moat score fell from its maximum of 0.98 (score of 1 indicates greatest economic moat).

The company also maintains a quantitative financial health rating of Strong. Its score sits at the 95th percentile in both the universe and sector.

Examining the company's financials and market statistics, we find these ratings are principally driven by its book value yield and annualized trailing 12-month volatility. The book value yield is 142.33%, sitting at the 65th percentile in the real estate sector. The company's annualized trailing 12-month volatility is 17.48%, corresponding to the 13th percentile in the equity coverage universe and the 27th percentile in the sector.

### Fundamentals as of 30 Nov 2024

The earnings per share for Domo Activos is 0.4. The company earns a return on invested capital of 18.8%, falling at the 95th percentile in the real estate sector. The company did not report a dividend. We calculate the above figures over a trailing 12-month period.

Examining valuation further, we find Domo Activos holds a price-to-earnings ratio of 3.17, a figure greater than 6% of its sector peers. The company's price-to-free cash flow ratio is 4.22, greater than 15% of its sector peers. These values are calculated using the stock's price at last market close.





# **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. ## **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

- iii. **Quantitative Star Rating:** Intended to be the summary rating based on the combination of our Quantitative Fair Value Estimate, current market price, Quantitative Uncertainty Rating, and momentum. The rating is expressed as One-Star, Two-Star, Three-Star, Four-Star, and Five-Star.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

**Very High** – the interquartile range for possible fair values is less than 80% but greater than 35%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
