



Business Description

Proeduca Altus SA is engaged in the business of providing online education. The business has its presence in Spain, Ecuador, Colombia, Mexico, Peru, Argentina, Bolivia and the USA.

Valuation ^Qas of 1 May 2024

Proeduca Altus achieves a 2-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 16.77, below the previous closing price of 19.50. The stock has been trading between a 4.76% discount and 20.48% premium to its quantitative fair value over the past year. The stock's current valuation rating sits at the 95th percentile in the coverage universe and 95th percentile in the consumer defensive sector (higher percentile indicates more undervalued). The quantitative uncertainty rating for Proeduca Altus is High.

Our quantitative star rating last differed from the current rating on 04/18/2024, when it was 3; the uncertainty rating remains unchanged over the last year.

The main drivers of the company's valuation and uncertainty are its EV-MV ratio and volatility. The enterprise value-to-market value ratio of 0.90 falls at the 27th percentile in the equity universe and the 15th percentile in its sector. The annualized trailing 12-month volatility of 18.45% corresponds to the 17th percentile overall and the 30th percentile in the industry.

Economic Moat as of 1 May 2024

With a Narrow Morningstar quantitative moat rating, the quantitative moat score for Proeduca Altus falls at the 93rd percentile in the consumer defensive sector and above the 95th in the equity cover-

age universe. The company has maintained its Narrow quantitative moat rating since after 04/29/2024, when it was downgraded from Wide.

We also assign a Strong quantitative financial health rating to Proeduca Altus. The company's raw score on this metric, termed Distance to Default, ranks at the 90th percentile overall and 94th in the consumer defensive sector. Furthermore, this financial health rating has stayed Strong over the last year

Supporting these ratings are the company's book value yield and annualized trailing 12-month volatility. The book value yield of 1.08%, ranks at the 7th percentile overall and among its peers. Meanwhile, its annualized trailing 12-month volatility of 18.45%, falls at the 17th percentile in the universe and the 30th percentile in the consumer defensive sector.

Fundamentals as of 1 May 2024

Proeduca Altus reports earnings per share of 0.77. Its return on invested capital is 247.48%. The company maintains a dividend yield of 6.13%, paying out 120.21% of earnings. These values are calculated over a trailing 12-month period.

As of last market close, Proeduca Altus has a price-to-earnings ratio of 25.22, falling at the 67th percentile in its sector (where a lower percentile means a lower ratio) and ranging between 21.59 and 27.65 over the past year. The company's price-to-free cash flow ratio is 15.76, falling at the 53rd percentile in its sector and ranging between 13.5 and 19.9 over the past year.





Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
