



#### **Business Description**

Plasticos Compuestos SA is engaged in n designing, producing, and selling mineral concentrates (fillers) and color and additive concentrates (masterbatches) for the plastic processing industry. The product portfolio includes color masterbatches, black masterbatches, white masterbatches, additives, compostable resins, and mineral concentrates.

#### Valuation as of 2 May 2024

Plasticos Compuestos achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 1.99, above the previous closing price of 1.07. The stock has been trading between a 61.28% and 21.5% discount to its quantitative fair value over the past year. The stock's current valuation rating sits at the 16th percentile in the coverage universe and 37th percentile in the basic materials sector (higher percentile indicates more undervalued).

The quantitative uncertainty rating for Plasticos Compuestos is Extreme.

Our quantitative star rating remains unchanged over the past year; the uncertainty rating last differed on 10/25/2023, when it was Very High.

The main drivers of the company's valuation and uncertainty are its EV-MV ratio and volume. The enterprise value-to-market value ratio of 1.68 falls at the 82nd percentile in the equity universe and the 89th percentile in its sector. The trailing 12-month average volume (primary share) of 88 shares corresponds to the 5th percentile overall and the 5th percentile in the industry.

Morningstar maintains a quantitative moat rating

of None on the company. The firm's quantitative moat score of 0.6 sits at the 69th percentile in the basic materials sector. This is a decrease from 0.93, the maximum of its moat scores over the past year. The quantitative financial health rating for Plasticos Compuestos is Moderate. Its financial health score, termed Distance to Default, sits at the 13th percentile in the universe and 12th percentile in the sector.

The significant drivers of these ratings are the company's book value yield and annualized trailing 12-month volatility. The book value yield for Plasticos Compuestos is 139.25%, and its annualized trailing 12-month volatility is 42.57%. They sit at the 82nd and 66th percentile in the global equity universe, respectively.





# **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. ### **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

**Very High** – the interquartile range for possible fair values is less than 80% but greater than 35%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
