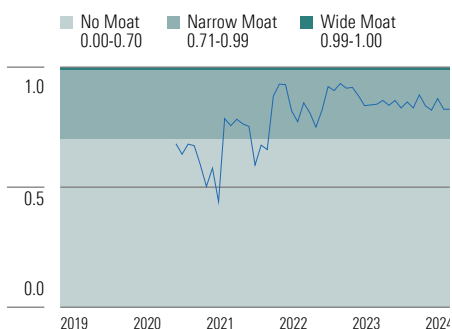

## Business Description

Izertis SA is a technology consulting company. The company is specialized in providing strategic digital transformation consulting services in areas like AI, Data & Intelligence, Cyber Security, Blockchain, Business solutions, and Smart Software labs.

## Valuation <sup>Q</sup> as of 24 Apr 2024

Izertis achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 8.93, in-line with the previous closing price of 8.74. The stock has been trading between a 12.66% discount and 11.75% premium to its quantitative fair value over the past year. The stock's current valuation rating sits at the 89th percentile in the coverage universe and 86th percentile in the technology sector (higher percentile indicates more undervalued).

The quantitative uncertainty rating for Izertis is High.

Our quantitative star rating remains unchanged over the past year; the uncertainty rating remains unchanged over the same period as well.

The main drivers of the company's valuation and uncertainty are its earnings yield and volatility. The earnings yield of 2.29% falls at the 47th percentile in the equity universe and the 59th percentile in its sector. The annualized trailing 12-month volatility of 12.51% corresponds to the 6th percentile overall and the 5th percentile in the industry.

## Economic Moat <sup>Q</sup> as of 24 Apr 2024

With a Narrow Morningstar quantitative moat rating, the quantitative moat score for Izertis falls at the 80th percentile in the technology sector and at the 81st in the equity coverage universe. The company has maintained its Narrow quantitative moat

rating since after 01/01/2024, when it was upgraded from None.

We also assign a Strong quantitative financial health rating to Izertis. The company's raw score on this metric, termed Distance to Default, ranks at the 75th percentile overall and in the technology sector. Furthermore, this financial health rating most recently changed from Moderate after 10/18/2023.

Supporting these ratings are the company's book value yield and annualized trailing 12-month volatility. The book value yield of 32.35%, ranks at the 30th percentile in the covered equity universe and at the 43rd percentile among its peers. Meanwhile, its annualized trailing 12-month volatility of 12.51%, falls at the 6th percentile in the universe and the 5th percentile in the technology sector.

## Fundamentals as of 24 Apr 2024

Izertis reports earnings per share of 0.2. Its return on invested capital is 6.28%. These values are calculated over a trailing 12-month period.

As of last market close, Izertis has a price-to-earnings ratio of 43.7, falling at the 73rd percentile in its sector (where a lower percentile means a lower ratio) and ranging between 42.3 and 57.38 over the past year. The company's price-to-free cash flow ratio is 21.82, falling at the 50th percentile in its sector and ranging between 17.02 and 26.84 over the past year.

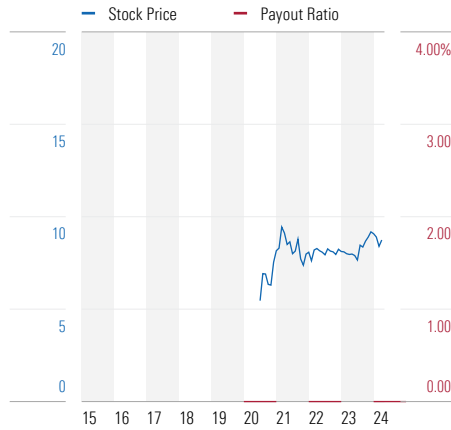

## Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. ### Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings").

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. i. **Quantitative Fair Value Estimate:** Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** – assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iii. **Quantitative Star Rating:** Intended to be the summary rating based on the combination of our Quantitative Fair Value Estimate, current market price, Quantitative Uncertainty Rating, and momentum. The rating is expressed as One-Star, Two-Star, Three-Star, Four-Star, and Five-Star.

After the initial calculation for the star rating, there is a final filtering step based on the momentum of the company. We rank the companies based on their 12-1 month momentum, then restrict those below the 30th percentile to a maximum of 3 stars.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

**Low** – the interquartile range for possible fair values is less than 10%

**Medium** – the interquartile range for possible fair values is less than 15% but greater than 10%

**High** – the interquartile range for possible fair values is less than 35% but greater than 15%

**Very High** – the interquartile range for possible fair values is less than 80% but greater than 35%

**Extreme** – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

**Weak** – assigned when Quantitative Financial Health < 0.2

**Moderate** – assigned when Quantitative Financial Health is between 0.2 and 0.7

**Strong** – assigned when Quantitative Financial Health > 0.7

### Other Definitions

i. **Last Close** – Price of the stock as of the close of the market of the last trading day before date of the report.

ii. **Quantitative Valuation** – Using the below terms, intended to denote the relationship between the security's **Last Price** and Morningstar's quantitative fair value estimate for that security.

**Undervalued – Last Price** is below Morningstar's quantitative fair value estimate.
