



#### **Business Description**

Izertis SA is a technology consulting company. The company is specialized in providing strategic digital transformation consulting services in areas like AI, Data & Intelligence, Cyber Security, Blockchain, Business solutions, and Smart Software labs.

### Valuation as of 4 Oct 2024

Izertis achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 10.88, above the previous closing price of 10.15. The stock has been trading between a 12.66% discount and 11.75% premium to its quantitative fair value over the past year. The stock's current valuation rating sits at the 82nd percentile in the coverage universe and 81st percentile in the technology sector.

The quantitative uncertainty rating for Izertis is High.

Our quantitative star rating remains unchanged over the past year; the uncertainty rating remains unchanged over the same period as well.

The main drivers of the company's valuation and uncertainty are its drawdown and volatility. The trailing 12-month maximum drawdown of 9.37% falls at the 8th percentile in the equity universe and the 5th percentile in its sector. The annualized trailing 12-month volatility of 11.68% corresponds to the 5th percentile overall and the 5th percentile in the industry.

### Economic Moat <sup>a</sup> as of 4 Oct 2024

With a Narrow Morningstar quantitative moat rating, the quantitative moat score for Izertis falls at the 79th percentile in both the technology sector and equity coverage universe. The company has maintained its Narrow quantitative moat rating

since after 07/31/2024, when it was upgraded from None

We also assign a Strong quantitative financial health rating to Izertis. The company's raw score on this metric, termed Distance to Default, ranks at the 77th percentile overall and 78th in the technology sector. Furthermore, this financial health rating most recently changed from Moderate after 10/18/2023

Supporting these ratings are the company's book value yield and annualized trailing 12-month volatility. The book value yield of 27.24%, ranks at the 27th percentile in the covered equity universe and at the 40th percentile among its peers. Meanwhile, its annualized trailing 12-month volatility of 11.68%, falls at the 5th percentile in both the universe and the technology sector.

### Fundamentals as of 4 Oct 2024

The earnings per share for Izertis is 0.2. The company earns a return on invested capital of 6.28%, falling at the 57th percentile in the technology sector. The company did not report a dividend. We calculate the above figures over a trailing 12-month period.

Examining valuation further, we find Izertis holds a price-to-earnings ratio of 50.75, a figure greater than 74% of its sector peers. The company's price-to-free cash flow ratio is 25.34, greater than 54% of its sector peers. These values are calculated using the stock's price at last market close.



# **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. ### **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

After the initial calculation for the star rating, there is a final filtering step based on the momentum of the company. We rank the companies based on their 12-1 month momentum, then restrict those below the 30th percentile to a maximum of 3 stars

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

 $\overrightarrow{\text{High}}-\text{the}$  interquartile range for possible fair values is less than 35% but greater than 15%

**Very High** – the interquartile range for possible fair values is less than 80% but greater than 35%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak − assigned when Quantitative Financial Health < 0.2

Moderate − assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7

### Other Definitions

- i. Last Close Price of the stock as of the close of the market of the last trading day before date of the report.
- Quantitative Valuation— Using the below terms, intended to denote the relationship between the security's Last Price and Morningstar's quantitative fair value estimate for that security.
