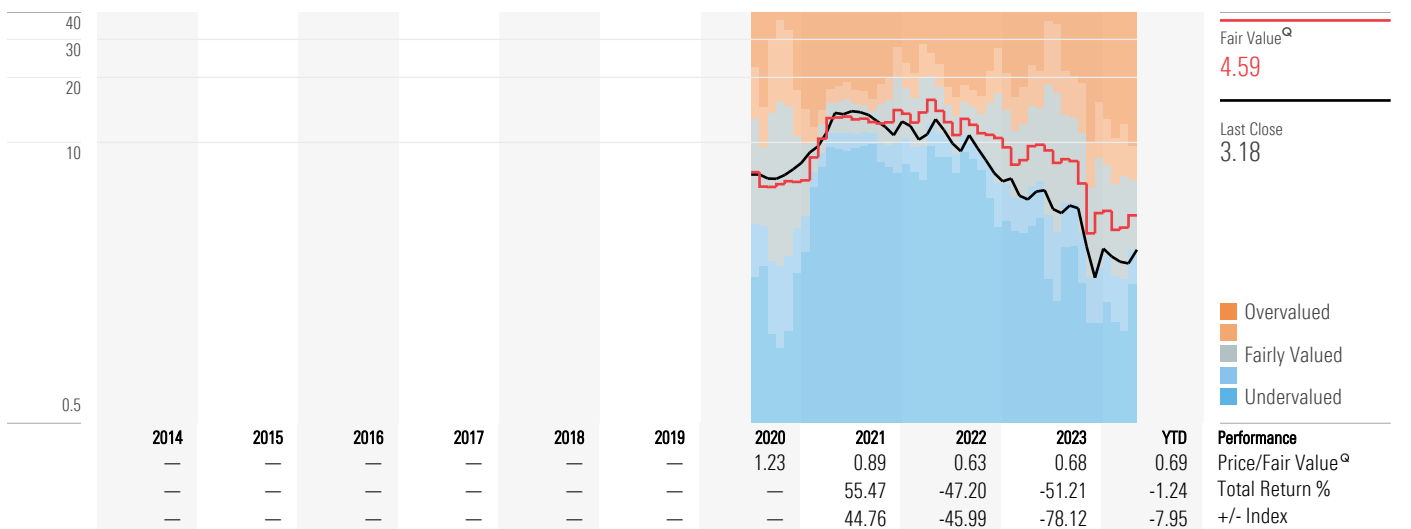

## Business Description

Holaluz-Clidom SA is a renewable energy company providing green energy. The company's main activity is commercialization of energy in general. Its Holaluz Cloud is a system that allows surplus energy, i.e. energy produced by customers' solar panels that cannot be consumed at the moment, to be deducted from the electricity bill.

## Valuation <sup>Q</sup> as of 17 Apr 2024

Morningstar maintains a 3-star quantitative star rating for Holaluz-Clidom, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 3.00, below our quantitative fair value estimate of 4.40. These shares have traded between a 51.53% and 23.1% discount to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 40th percentile; in the utilities sector, the firm's score lies at the 27th percentile (higher percentile indicates more undervalued).

Furthermore, Holaluz-Clidom maintains a quantitative valuation uncertainty rating of Extreme.

The company has held this star rating over the past year. The uncertainty rating for Holaluz-Clidom has remained Extreme since the previous rating of Very High, which was last assigned on 04/12/2024.

The key factors behind these ratings are the company's EV-MV ratio and volatility. The enterprise value-to-market value ratio is 1.70, and its maximum annualized trailing 12-month volatility is 73.75%. The EV-MV ratio falls at the 59th percentile in the utilities sector while the volatility is at the 93rd percentile. Over the past year, the company's EV-MV ratio has been between 1.30 and 2.04; its volatility has ranged between 28.20% and 73.75%.

With a Morningstar quantitative moat rating of None, the quantitative moat score for Holaluz-Clidom falls at the 67th percentile in the utilities sector and at the 70th in the equity coverage universe. The company has maintained its None quantitative moat rating since after 04/10/2024, when it was downgraded from Narrow.

We also assign a Moderate quantitative financial health rating to Holaluz-Clidom. The company's raw score on this metric, termed Distance to Default, ranks at the 6th percentile overall and 5th in the utilities sector. Furthermore, this financial health rating most recently changed from Weak after 03/26/2024.

Supporting these ratings are the company's enterprise value and enterprise value-to-market value ratio. The enterprise value of 118.58 million, ranks at the 40th percentile in the covered equity universe and at the 19th percentile among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.70, falls at the 82nd percentile in the universe and the 59th percentile in the utilities sector.

## Fundamentals as of 17 Apr 2024

Holaluz-Clidom maintains losses per share of -1.44. The company further earns a return on invested capital of -45.75%. These values are calculated over a trailing 12-month period.

As of last market close, the company's price-to-free cash flow ratio is 22.7, falling at the 76th percentile in its sector and ranging between 8.32 and 251.56 over the past year.

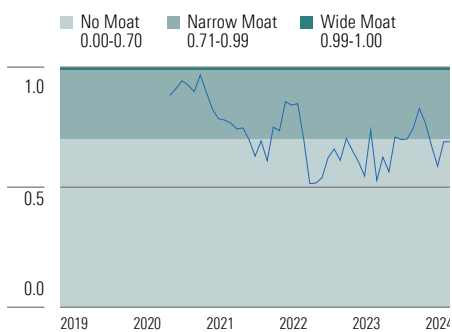

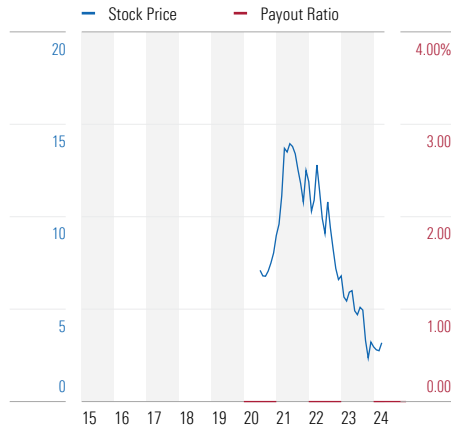

## Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. ### Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings").

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

i. **Quantitative Fair Value Estimate:** Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** – assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iii. **Quantitative Star Rating:** Intended to be the summary rating based on the combination of our Quantitative Fair Value Estimate, current market price, Quantitative Uncertainty Rating, and momentum. The rating is expressed as One-Star, Two-Star, Three-Star, Four-Star, and Five-Star.

After the initial calculation for the star rating, there is a final filtering step based on the momentum of the company. We rank the companies based on their 12-1 month momentum, then restrict those below the 30th percentile to a maximum of 3 stars.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

**Low** – the interquartile range for possible fair values is less than 10%

**Medium** – the interquartile range for possible fair values is less than 15% but greater than 10%

**High** – the interquartile range for possible fair values is less than 35% but greater than 15%

**Very High** – the interquartile range for possible fair values is less than 80% but greater than 35%

**Extreme** – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

**Weak** – assigned when Quantitative Financial Health < 0.2

**Moderate** – assigned when Quantitative Financial Health is between 0.2 and 0.7

**Strong** – assigned when Quantitative Financial Health > 0.7

### Other Definitions

i. **Last Close** – Price of the stock as of the close of the market of the last trading day before date of the report.

ii. **Quantitative Valuation** – Using the below terms, intended to denote the relationship between the security's **Last Price** and Morningstar's quantitative fair value estimate for that security.

**Undervalued – Last Price** is below Morningstar's quantitative fair value estimate.

**Fairly Valued – Last Price** is in line with Morningstar's quantitative fair value estimate.

**Fairly Valued – Last Price** is in line with Morningstar's quantitative fair value estimate.
