

Business Description

Making Science Group SA is engaged in the business of technology and marketing solutions for the digital business. The company provides solutions in areas of digital marketing, data analytics, e-commerce, and cloud. The company carries out its professional activity in 10 countries: United States, Spain, Portugal, Ireland, Georgia, Italy, France, United Kingdom, Mexico, Colombia. The Company obtains its income mainly from advertising and public relations services.

Valuation[®]as of 3 May 2024

Making Science Group achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 11.86, above the previous closing price of 8.95. The stock has been trading between a 48.3% and 15.33% discount to its quantitative fair value over the past year. The stock's current valuation rating sits at the 49th percentile in the coverage universe and 56th percentile in the communication services sector (higher percentile indicates more undervalued).

The quantitative uncertainty rating for Making Science Group is Very High.

Our quantitative star rating remains unchanged over the past year; the uncertainty rating last differed on 01/17/2024, when it was Extreme.

The main drivers of the company's valuation and uncertainty are its EV-MV ratio and drawdown. The enterprise value-to-market value ratio of 1.55 falls at the 79th percentile in the equity universe and the 76th percentile in its sector. The trailing 12month maximum drawdown of 25.89% corresponds to the 43rd percentile overall and the 41st percentile in the industry.

Economic Moat ^Qas of 3 May 2024

Morningstar maintains a Narrow quantitative moat rating on the company. The firm's quantitative moat score of 0.83 sits at the 79th percentile in the communication services sector. This is a decrease from 0.86, the maximum of its moat scores over the past year

The quantitative financial health rating for Making Science Group is Moderate. Its financial health score, termed Distance to Default, sits at the 30th percentile in the universe and 32nd percentile in the sector.

The significant drivers of these ratings are the company's book value yield and annualized trailing 12month volatility. The book value yield for Making Science Group is 11.63%, and its annualized trailing 12-month volatility is 28.86%. They sit at the 13th and 43rd percentile in the global equity universe, respectively.

Fundamentals as of 3 May 2024

Making Science Group reports losses per share of -1.06. Its return on invested capital is -9.24%. These values are calculated over a trailing 12-month period

As of last market close, the company's price-to-free cash flow ratio is 71.36, falling at the 92nd percentile in its sector and ranging between 9.61 and 90.82 over the past year.



Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

After the initial calculation for the star rating, there is a final filtering step based on the momentum of the company. We rank the companies based on their 12-1 month momentum, then restrict those below the 30th percentile to a maximum of 3 stars.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10% Medium – the interquartile range for possible fair values is less than 15% but greater than 10%

High – the interquartile range for possible fair values is less than 35% but greater than 15%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak – assigned when Quantitative Financial Health < 0.2

Strong - assigned when Quantitative Financial Health > 0.7

i. Last Close – Price of the stock as of the close of the market of the last trading day before date of the report.

ii. **Quantitative Valuation**– Using the below terms, intended to denote the relationship between the security's **Last Price** and Morningstar's quantitative fair value estimate for that security.

Undervalued – Last Price is below Morningstar's quantitative fair value estimate.

Farily Valued – Last Price is in line with Morningstar's quantitative fair value estimate.
