



Business Description

Energia Innovacion Y Desarrollo Fotovoltaico SA is a company specialized in photovoltaic solar energy projects. It offers engineering services, energy consulting, and installation of low and medium voltage. It is engaged in self-consumption photovoltaic installations for companies. Some of its projects are Generation park-Pulpi I, Fricosa, Barcia pipes, Peregrin One Garlic among others.

Valuation as of 3 May 2024

Morningstar affirms a 3-star quantitative rating for Energia Innovacion. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 6.45, a discount of 33.67% to its Quantitative Fair Value estimate of 9.72. The stock has been trading between a 52.87% discount and 25.18% premium to its quantitative fair value over the past year. The stock's price to fair value ratio is at the 33rd percentile in our global equity coverage universe for this methodology and at the 27th percentile relative to its peers in the technology sector.

Energia Innovacion furthermore holds a Extreme quantitative uncertainty rating.

The company's quantitative star rating dates to after 08/28/2023, before which it was 4-star. Similarly, the firm's uncertainty rating changed from Very High to Extreme after 04/09/2024.

We examine the financials and market statistics for Energia Innovacion to determine these ratings. Its annualized trailing 12-month volatility is 121.44% and falls at the 93rd percentile in the equity universe and at the 93rd percentile in the technology sector.

Economic Moat as of 3 May 2024

Quantitatively, we do not believe Energia Innova-

cion has an economic moat. Its moat score of 0.62 corresponds to the 66th percentile in the technology sector. Furthermore, this rating last differed from its previous rating of Narrow on 04/09/2024, when the company's moat score fell from its maximum of 0.99 (score of 1 indicates greatest economic moat).

The company also maintains a quantitative financial health rating of Moderate. Its score sits at the 9th percentile in both the universe and sector.

Examining the company's financials and market statistics, we find these ratings are principally driven by its enterprise value and enterprise value-tomarket value ratio. The enterprise value is 477.44 million, sitting at the 58th percentile in the technology sector. The company's enterprise value-tomarket value ratio is 1.17, corresponding to the 62nd percentile in the equity coverage universe and the 76th percentile in the sector.

Fundamentals as of 3 May 2024

Energia Innovacion reports losses per share of -0.16. Its return on invested capital is -3.46%. These values are calculated over a trailing 12-month period.



Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

 $\bar{\text{\textbf{High}}}$ — the interquartile range for possible fair values is less than 35% but greater than 15%

Very High – the interquartile range for possible fair values is less than 80% but greater than 35%

Extreme – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7
