



Business Description

Parlem Telecom Companyia De Telecomunicacions SA is the telecommunications operator. It offers comprehensive mobile, internet, landline and television services and aspires to provide service to customers in any corner of the world to both individuals and companies.

Valuation as of 30 Apr 2024

Morningstar affirms a 3-star quantitative rating for Parlem Telecom Companyia. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 3.48, a discount of 30.95% to its Quantitative Fair Value estimate of 5.04. This discount has ranged between 58.86% and 18.32% over the past year. The stock's price to fair value ratio is at the 41st percentile in our global equity coverage universe for this methodology and at the 48th percentile relative to its peers in the communication services sector.

Parlem Telecom Companyia furthermore holds a Extreme quantitative uncertainty rating.

The company's quantitative star rating remains unchanged over the past year. The firm's uncertainty rating changed from Very High to Extreme after 04/26/2024.

We examine the financials and market statistics for Parlem Telecom Companyia to determine these ratings. Its enterprise value-to-market value ratio is 1.45 and its trailing 12-month average volume (primary share) is 7,774 shares. These fall at the 76th and 17th percentiles in the equity universe and at the 72nd and 17th in the communication services sector, respectively.

Economic Moat ^Q as of 30 Apr 2024

With a Morningstar quantitative moat rating of None, the quantitative moat score for Parlem Telecom Companyia falls at the 70th percentile in the communication services sector and at the 71st in the equity coverage universe. The company has maintained its None quantitative moat rating since after 04/26/2024, when it was downgraded from Narrow.

We also assign a Moderate quantitative financial health rating to Parlem Telecom Companyia. The company's raw score on this metric, termed Distance to Default, ranks at the 26th percentile overall and 29th in the communication services sector. Furthermore, this financial health rating has stayed Moderate over the last year.

Supporting these ratings are the company's enterprise value and annualized trailing 12-month volatility. The enterprise value of 89.54 million, ranks at the 36th percentile in the covered equity universe and at the 39th percentile among its peers. Meanwhile, its annualized trailing 12-month volatility of 32.40%, falls at the 50th percentile in the universe and the 48th percentile in the communication services sector.

Fundamentals as of 30 Apr 2024

Parlem Telecom Companyia reports losses per share of -0.52. Its return on invested capital is -28.25%. These values are calculated over a trailing 12-month period.





Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

High – the interquartile range for possible fair values is less than 35% but greater than 15%

Very High – the interquartile range for possible fair values is less than 80% but greater than 35%

Extreme – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7

Other Definitions

- i. Last Close Price of the stock as of the close of the market of the last trading day before date of the report.
- Quantitative Valuation— Using the below terms, intended to denote the relationship between the security's Last Price and Morningstar's quantitative fair value estimate for that security.
