



Business Description

Silicius Real Estate Socimi SA specializes in the purchase and active management of real estate assets that generate stable income for its shareholders and provide them with an annual coupon. The company's portfolio of assets include retail, office, hotels, shopping centres, residential and others.

Valuation as of 3 May 2024

Morningstar maintains a 3-star quantitative star rating for Silicius Real Estate, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 14.20, below our quantitative fair value estimate of 15.97. These shares have traded between a 20.88% discount and 4.51% premium to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 76th percentile; in the real estate sector, the firm's score lies at the 87th percentile (meaning the shares are more undervalued than 87% of stocks in the sector).

Furthermore, Silicius Real Estate maintains a quantitative valuation uncertainty rating of Very High.

The company has held this star rating over the past year. The uncertainty rating for Silicius Real Estate has remained Very High since the previous rating of High, which was last assigned on 05/25/2023. The key factors behind these ratings are the company's EV-MV ratio and earnings yield. The enterprise value-to-market value ratio is 1.86, and its

prise value-to-market value ratio is 1.86, and its maximum earnings yield is 3.10%. The EV-MV ratio falls at the 55th percentile in the real estate sector while the earnings yield is at the 53rd percentile. Over the past year, the company's EV-MV ratio has been between 1.30 and 2.00; its earnings yield has ranged between 3.10% and 3.10%.

Economic Moat ^Qas of 3 May 2024

With a Narrow Morningstar quantitative moat rating, the quantitative moat score for Silicius Real Estate falls above the 95th percentile in the real estate sector and at the 93rd in the equity coverage universe. The company has maintained its Narrow quantitative moat rating since after 11/27/2023, when it was downgraded from Wide.

We also assign a Moderate quantitative financial health rating to Silicius Real Estate. The company's raw score on this metric, termed Distance to Default, ranks at the 69th percentile overall and 84th in the real estate sector. Furthermore, this financial health rating most recently changed from Strong after 05/01/2024.

Supporting these ratings are the company's sales yield and enterprise value-to-market value ratio. The sales yield of 6.29%, ranks at the 14th percentile in the covered equity universe and at the 9th percentile among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.86, falls at the 85th percentile in the universe and the 55th percentile in the real estate sector.

Fundamentals as of 3 May 2024

Silicius Real Estate reports losses per share of 0.88. Its return on invested capital is -1.76%. These values are calculated over a trailing 12-month period.





Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

 $\bar{\text{\textbf{High}}}$ — the interquartile range for possible fair values is less than 35% but greater than 15%

Very High – the interquartile range for possible fair values is less than 80% but greater than 35%

Extreme – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7
