## Business Description

Endurance Motive SA designs and assembles lithium batteries for electromobility. It offers complete solutions for the implementation of lithium-based storage technology for industrial traction equipment, naval sector and public transport vehicles.

## Valuation as of 19 Apr 2024

Endurance Motive achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system. The Quantitative Fair Value estimate is 1.68, above the previous closing price of 1.41. The stock has been trading between a 45.08% and 1.67% discount to its quantitative fair value over the past year. The stock's current valuation rating sits at the 69th percentile in the coverage universe and 52nd percentile in the industrials sector (higher percentile indicates more undervalued).

The quantitative uncertainty rating for Endurance Motive is Very High.

Our quantitative star rating remains unchanged over the past year; the uncertainty rating last differed on 03/04/2024, when it was Extreme.

The main drivers of the company's valuation and uncertainty are its volatility and earnings yield. The annualized trailing 12-month volatility of 86.44% falls at the 88th percentile in the equity universe and the 95th percentile in its sector. The earnings yield of -2.54% corresponds to the 32nd percentile overall and the 19th percentile in the industry.

## Economic Moat as of 19 Apr 2024

Quantitatively, we do not believe Endurance Motive has an economic moat. Its moat score of 0.67 corresponds to the 60th percentile in the industrials sector. Furthermore, this rating last differed from its previous rating of Narrow on 04/

17/2024, when the company's moat score fell from its maximum of 0.83 (score of 1 indicates greatest economic moat).

The company also maintains a quantitative financial health rating of Moderate. Its score sits at the 19th percentile overall and the 17th percentile in the sector.

Examining the company's financials and market statistics, we find these ratings are principally driven by its enterprise value and enterprise value-to-market value ratio. The enterprise value is 14.65 million, sitting at the 10th percentile in the industrials sector. The company's enterprise value-to-market value ratio is 1.00, corresponding to the 44th percentile in the equity coverage universe and the 35th percentile in the sector.

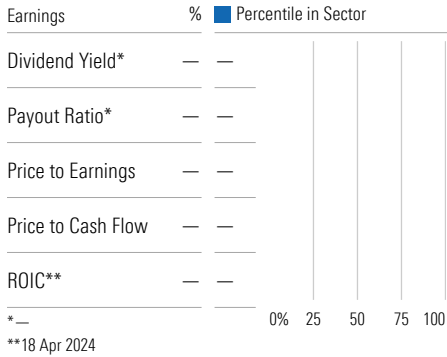

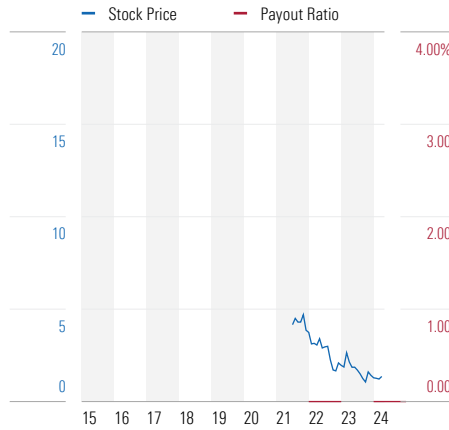

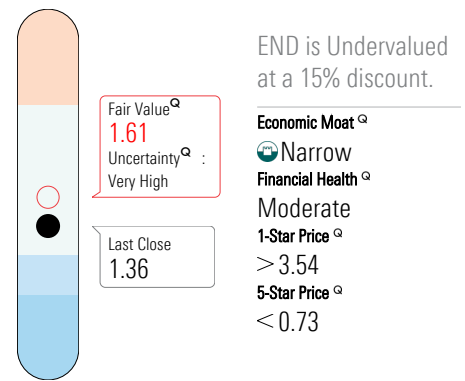
## Earnings as of 18 Apr 2024

## Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** – assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

**Low** – the interquartile range for possible fair values is less than 10%

**Medium** – the interquartile range for possible fair values is less than 15% but greater than 10%

**High** – the interquartile range for possible fair values is less than 35% but greater than 15%

**Very High** – the interquartile range for possible fair values is less than 80% but greater than 35%

**Extreme** – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

**Weak** – assigned when Quantitative Financial Health < 0.2

**Moderate** – assigned when Quantitative Financial Health is between 0.2 and 0.7

**Strong** – assigned when Quantitative Financial Health > 0.7

### Other Definitions

i. **Last Close** – Price of the stock as of the close of the market of the last trading day before date of the report.

ii. **Quantitative Valuation** – Using the below terms, intended to denote the relationship between the security's **Last Price** and Morningstar's quantitative fair value estimate for that security.

**Undervalued – Last Price** is below Morningstar's quantitative fair value estimate.
