


Business Description

Club De Futbol Intercity SAD is a soccer club in San Juan de Alicante that plays in the Spanish third division

Valuation as of 23 Nov 2024

Morningstar maintains a 3-star quantitative star rating for Club De Futbol Intercity, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 0.53, below our quantitative fair value estimate of 0.83. These shares have traded between a 56.16% and 25.38% discount to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 34th percentile; in the communication services sector, the firm's score lies at the 33rd percentile.

Furthermore, Club De Futbol Intercity maintains a quantitative valuation uncertainty rating of Extreme.

The company has held this star rating over the past year. The uncertainty rating for Club De Futbol Intercity has remained Extreme since the previous rating of Very High, which was last assigned on 11/06/2024.

The key factors behind these ratings are the company's sales yield and volatility. The sales yield is 180.41%, and its maximum annualized trailing 12-month volatility is 97.06%. The sales yield falls at the 78th percentile in the communication services sector while the volatility is at the 89th percentile. Over the past year, the company's sales yield has been between 53.30% and 316.17%; its volatility has ranged between 72.86% and 97.06%.

Economic Moat ^Q as of 22 Nov 2024

Morningstar maintains a quantitative moat rating of None on the company. The firm's quantitative

moat score of 0.67 sits at the 68th percentile in the communication services sector. This is a decrease from 0.77, the maximum of its moat scores over the past year.

The quantitative financial health rating for Club De Futbol Intercity is Moderate. Its financial health score, termed Distance to Default, sits at the 23rd percentile in the universe and 26th percentile in the sector.

The significant drivers of these ratings are the company's enterprise value and enterprise value-to-market value ratio. The enterprise value for Club De Futbol Intercity is 2.74 million, and its enterprise value-to-market value ratio is 0.98. They sit at the 8th and 38th percentile in the global equity universe, respectively.

Fundamentals as of 22 Nov 2024

The earnings per share for Club De Futbol Intercity is -0.14. We do not have enough information to report on the company's return-on-invested-capital and dividend yield. The company did not report a dividend.





Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7
