



#### **Business Description**

Club De Futbol Intercity SAD is a soccer club in San Juan de Alicante that plays in the Spanish third division.

### Valuation <sup>Q</sup>as of 7 May 2024

Morningstar maintains a 3-star quantitative star rating for Club De Futbol Intercity, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 0.0352, below our quantitative fair value estimate of 0.0602. These shares have traded between a 73.01% and 24.52% discount to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 18th percentile; in the communication services sector, the firm's score lies at the 16th percentile (higher percentile indicates more undervalued).

Furthermore, Club De Futbol Intercity maintains a quantitative valuation uncertainty rating of Extreme.

The company has held this star rating over the past year. The uncertainty rating for Club De Futbol Intercity has remained Extreme over the past year. The key factors behind these ratings are the company's sales yield and volatility. The sales yield is 289.23%, and its maximum annualized trailing 12month volatility is 117.67%. The sales yield falls at the 88th percentile in the communication services sector while the volatility is at the 87th percentile. Over the past year, the company's sales yield has been between 21.62% and 308.51%; its volatility has ranged between 72.86% and 117.67%.

### Economic Moat <sup>°</sup>as of 7 May 2024

Morningstar maintains a quantitative moat rating of None on the company. The firm's quantitative moat score of 0.5 sits at the 54th percentile in the communication services sector. This is a decrease from 0.68, the maximum of its moat scores over the past year.

The quantitative financial health rating for Club De Futbol Intercity is Moderate. Its financial health score, termed Distance to Default, sits at the 9th percentile in the universe and 12th percentile in the sector.

The significant drivers of these ratings are the company's enterprise value and enterprise value-tomarket value ratio. The enterprise value for Club De Futbol Intercity is 1.20 million, and its enterprise value-to-market value ratio is 1.29. They sit at the 5th and above the 69th percentile in the global equity universe, respectively.

#### Fundamentals as of 7 May 2024

Club De Futbol Intercity reports losses per share of -0.49. We do not have enough information to report on the company's return-on-invested-capital and dividend yield.



## Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. ## **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analystdriven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

i. **Quantitative Fair Value Estimate:** Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** – assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iii. **Quantitative Star Rating:** Intended to be the summary rating based on the combination of our Quantitative Fair Value Estimate, current market price, Quantitative Uncertainty Rating, and momentum. The rating is expressed as One-Star, Two-Star, Three-Star, Four-Star, and Five-Star.

After the initial calculation for the star rating, there is a final filtering step based on the momentum of the company. We rank the companies based on their 12-1 month momentum, then restrict those below the 30th percentile to a maximum of 3 stars.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10% Medium – the interquartile range for possible fair values is less than 15% but greater than 10%

**High** – the interquartile range for possible fair values is less than 35% but greater than 15%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak – assigned when Quantitative Financial Health < 0.2

Strong - assigned when Quantitative Financial Health > 0.7

i. Last Close – Price of the stock as of the close of the market of the last trading day before date of the report.

ii. **Quantitative Valuation**– Using the below terms, intended to denote the relationship between the security's **Last Price** and Morningstar's quantitative fair value estimate for that security.

Sustainalytics analyzes over 1,300 data points to assess a company's exposure to and management of ESG risks. In other words, ESG Risk Ratings measures a company's unmanaged ESG Risks represented as a quantitative score. Unmanaged Risk is measured on an open-ended scale starting at zero (no risk) with lower scores representing less unmanaged risk and, for 95% of cases, the unmanaged ESG Risk score is below 50.
