



Business Description

Singular People SA is a software company. The company provides solutions to various industries including Energy & Utilities, Financial Services, Healthcare, Manufacturing, Retail, Museums, and Public services.

Valuation ^Qas of 3 May 2024

Singular People achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 3.58, above the previous closing price of 3.10. The stock has been trading between a 24.38% discount and 6.23% premium to its quantitative fair value over the past year. The stock's current valuation rating sits at the 72nd percentile in the coverage universe and 69th percentile in the technology sector (higher percentile indicates more undervalued).

The quantitative uncertainty rating for Singular People is Very High.

Our quantitative star rating last differed from the current rating on 11/01/2023; the uncertainty rating last differed on 04/29/2024. The previous ratings were 4 and High, respectively.

The main drivers of the company's valuation and uncertainty are its return on assets and drawdown. The return on assets of 10.22 falls at the 89th percentile in the equity universe and the 85th percentile in its sector. The trailing 12-month maximum drawdown of 27.04% corresponds to the 45th percentile overall and the 36th percentile in the industry.

Economic Moat ^Q as of 3 May 2024

With a Narrow Morningstar quantitative moat rating, the quantitative moat score for Singular People falls at the 79th percentile in the technology sector

and at the 78th in the equity coverage universe. The company has maintained its Narrow quantitative moat rating since after 05/01/2024, when it was upgraded from None.

We also assign a Moderate quantitative financial health rating to Singular People. The company's raw score on this metric, termed Distance to Default, ranks at the 64th percentile overall and 63rd in the technology sector. Furthermore, this financial health rating most recently changed from Strong after 09/22/2023.

Supporting these ratings are the company's book value yield and enterprise value-to-market value ratio. The book value yield of 27.39%, ranks at the 26th percentile in the covered equity universe and at the 38th percentile among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.03, falls at the 49th percentile in the universe and the 61st percentile in the technology sector.

Fundamentals as of 3 May 2024

Singular People maintains earnings per share of 0.14. The company further earns a return on invested capital of 13.2%. The shares offer a dividend yield of 1.3%. These values are calculated over a trailing 12-month period.

As of last market close, Singular People has a price-to-earnings ratio of 22.84, falling below the 45th percentile in its sector (where a lower percentile means a lower ratio) and ranging between 21.81 and 30.26 over the past year. The company's price-to-free cash flow ratio is 26.28, falling at the 58th percentile in its sector and ranging between 25.09 and 32.6 over the past year.



Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

 $\bar{\text{\textbf{High}}}$ — the interquartile range for possible fair values is less than 35% but greater than 15%

Very High – the interquartile range for possible fair values is less than 80% but greater than 35%

Extreme – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7
