


Business Description

Inkemia IUCT Group SA is a biotechnology company engaged in manufacturing and commercialization of biopharmaceutical products. The company operates in chemical, cosmetic, pharmacist, biotechnology, and food-related sectors.

Valuation as of 30 Nov 2024

Morningstar maintains a 3-star quantitative star rating for 1nkemia IUCT Group, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 0.30, in-line with our quantitative fair value estimate of 0.31. These shares have traded between a 12.52% discount and 36.33% premium to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 83rd percentile; in the healthcare sector, the firm's score lies at the 86th percentile.

Furthermore, 1nkemia IUCT Group maintains a quantitative valuation uncertainty rating of Extreme.

The company has held this star rating over the past year. The uncertainty rating for 1nkemia IUCT Group has remained Extreme since the previous rating of Very High, which was last assigned on 09/05/2024.

The key factors behind these ratings are the company's return on assets and drawdown. The return on assets is -1.76, and its maximum trailing 12-month maximum drawdown is 0.00%. The return on assets falls at the 58th percentile in the health-care sector while the drawdown is at the 5th percentile. Over the past year, the company's return on assets has been between -1.76 and 6.52; its drawdown has ranged between 0.00% and 0.00%.

With a Narrow Morningstar quantitative moat rating, the quantitative moat score for 1nkemia IUCT Group falls at the 85th percentile in the healthcare sector and at the 86th in the equity coverage universe. The company has maintained its Narrow quantitative moat rating for the last year.

We also assign a Moderate quantitative financial health rating to 1nkemia IUCT Group. The company's raw score on this metric, termed Distance to Default, ranks at the 68th percentile overall and 71st in the healthcare sector. Furthermore, this financial health rating most recently changed from Strong after 07/08/2024.

Supporting these ratings are the company's book value yield and enterprise value-to-market value ratio. The book value yield of -97.15%, ranks at the 5th percentile in the covered equity universe and at the 6th percentile among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.71, falls at the 82nd percentile in the universe and the 88th percentile in the healthcare sector.



Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
