



Business Description

Vousse Corp SA operates a medical aesthetic clinic network, offering non-invasive services. It specializes in hair removal through the application of the Alejandrita laser technology.

Valuation as of 7 May 2024

Vousse achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 0.39, in-line with the previous closing price of 0.40. The stock has been trading between a 18.2% discount and 10.81% premium to its quantitative fair value over the past year. The stock's current valuation rating sits at the 92nd percentile in the coverage universe and 92nd percentile in the consumer cyclical sector (higher percentile indicates more undervalued).

Our quantitative star rating remains unchanged over the past year; the uncertainty rating last differed on 09/07/2023, when it was Very High. The main drivers of the company's valuation and uncertainty are its earnings yield and drawdown. The earnings yield of 1.91% falls at the 45th percentile in the equity universe and the 37th percentile in its sector. The trailing 12-month maximum drawdown of 0.00% corresponds to the 5th percentile overall and the 5th percentile in the in-

dustry.

Morningstar maintains a Narrow quantitative moat rating on the company. The firm's quantitative moat score of 0.91 sits at the 91st percentile in the consumer cyclical sector. This is a decrease from 0.99, the maximum of its moat scores over the past

vear.

The quantitative financial health rating for Vousse is Strong. Its financial health score, termed Distance to Default, sits at the 75th percentile in the universe and 80th percentile in the sector.

The significant drivers of these ratings are the company's enterprise value-to-market value ratio and enterprise value-to-market value ratio. The enterprise value-to-market value ratio for Vousse is 1.43, and its enterprise value-to-market value ratio is 1.43. They sit at the 75th and 75th percentile in the global equity universe, respectively.

Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. - i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

High – the interquartile range for possible fair values is less than 35% but greater than 15%

Very High – the interquartile range for possible fair values is less than 80% but greater than 35%

v. Quantitative Financial Health: Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7
