



#### **Business Description**

Zinkia Entertainment SA is engaged in the entertainment sector. It develops and produces television series, movies, and video games. The company's brand profile includes Pocoyo, Mola Noguru, Shuriken School, and others. Its series and apps are distributed on different platforms and devices such as TV, VOD, DVD, mobile devices, YouTube, among others.

#### Valuation as of 3 May 2024

Zinkia Entertainment achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 0.60, above the previous closing price of 0.57. The stock has been trading between a 22.9% discount and 1.94% premium to its quantitative fair value over the past year. The stock's current valuation rating sits at the 85th percentile in the coverage universe and 88th percentile in the communication services sector (higher percentile indicates more undervalued).

The quantitative uncertainty rating for Zinkia Entertainment is Very High.

Our quantitative star rating remains unchanged over the past year; the uncertainty rating last differed on 03/13/2024, when it was Extreme.

The main drivers of the company's valuation and uncertainty are its EV-MV ratio and earnings yield. The enterprise value-to-market value ratio of 1.51 falls at the 78th percentile in the equity universe and the 74th percentile in its sector. The earnings yield of 0.87% corresponds to the 40th percentile overall and the 47th percentile in the industry.

### Economic Moat <sup>a</sup>as of 3 May 2024

With a Narrow Morningstar quantitative moat rating, the quantitative moat score for Zinkia Enter-

tainment falls at the 87th percentile in the communication services sector and at the 90th in the equity coverage universe. The company has maintained its Narrow quantitative moat rating for the last year.

We also assign a Moderate quantitative financial health rating to Zinkia Entertainment. The company's raw score on this metric, termed Distance to Default, ranks at the 73rd percentile overall and in the communication services sector. Furthermore, this financial health rating most recently changed from Strong after 04/02/2024.

Supporting these ratings are the company's enterprise value-to-market value ratio and enterprise value-to-market value ratio. The enterprise value-to-market value ratio of 1.51, ranks at the 78th percentile in the covered equity universe and at the 74th percentile among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.51, falls at the 78th percentile in the universe and the 74th percentile in the communication services sector.





### **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. ### **Quantitative Equity Ratings**

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. - i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

 $\bar{\text{\textbf{High}}}$  — the interquartile range for possible fair values is less than 35% but greater than 15%

**Very High** – the interquartile range for possible fair values is less than 80% but greater than 35%

**Extreme** – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7
