



#### **Business Description**

Biotechnology Assets SA is a clinical-stage biopharmaceutical company developing and producing biological products for the pharmaceutical and veterinarian sectors. It specializes in the prevention and treatment of niche diseases, such as orphan disease, antigens for new-generation vaccines, feed additives, and probiotics. Adl Bionatur offers a portfolio of non-therapeutic and therapeutic products to tier 1 and tier 2 animal health companies. The company's pipeline products include BNT006, BNT007, BNT010, and others.

### Valuation <sup>Q</sup>as of 8 May 2024

Morningstar maintains a 3-star quantitative star rating for Biotechnology Assets, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 0.33, below our quantitative fair value estimate of 0.48. These shares have traded between a 50.87% and 20.03% discount to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 36th percentile; in the healthcare sector, the firm's score lies at the 56th percentile (meaning the shares are more undervalued than 56% of stocks in the sector).

Furthermore, Biotechnology Assets maintains a quantitative valuation uncertainty rating of Very High.

The company has held this star rating over the past year. The uncertainty rating for Biotechnology Assets has remained Very High since the previous rating of Extreme, which was last assigned on 05/06/2024.

The key factors behind these ratings are the company's earnings yield and drawdown. The earnings yield is 8.19%, and its maximum trailing 12-month maximum drawdown is 57.66%. The earnings yield

falls above the 95th percentile in the healthcare sector while the drawdown is at the 30th percentile. Over the past year, the company's earnings yield has ranged between 12.63% and -11.28%; its drawdown has ranged between 57.66% and 27.14%.

## Economic Moat <sup>Q</sup> as of 8 May 2024

Quantitatively, we do not believe Biotechnology Assets has an economic moat. Its moat score of 0.33 corresponds to the 35th percentile in the healthcare sector. Furthermore, this rating has not changed over the past year, while the company's moat score fell from its maximum of 0.56 in this period (score of 1 indicates greatest economic moat).

The company also maintains a quantitative financial health rating of Moderate. Its score sits at the 21st percentile overall and the 23rd percentile in the sector

Examining the company's financials and market statistics, we find these ratings are principally driven by its book value yield and annualized trailing 12-month volatility. The book value yield is 34.77%, sitting at the 51st percentile in the healthcare sector. The company's annualized trailing 12-month volatility is 38.21%, corresponding to the 60th percentile in the equity coverage universe and the 40th percentile in the sector.


Biotechnology Assets maintains earnings per share of 0.03. The company further earns a return on invested capital of 16.55%. These values are calculated over a trailing 12-month period.


As of last market close, Biotechnology Assets has a price-to-earnings ratio of 12.21, falling below the 16th percentile in its sector (where a lower per-

# **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. ## **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
