Results of the Ordinary Review of the IBEX MAB® ALL SHARE and IBEX MAB® 15 Indices

At its follow up meeting on March 13th, the Technical Advisory Committee, in accordance with the Technical Regulations for the Composition and Calculation of the IBEX® Indices has decided the following changes in IBEX MAB® Indices' constituents:

IBEX MAB® ALL SHARE:

- **Stocks undergoing a change in free float factor due to changes in block ownership:**

Following the exclusion of the stock GREENERGY RENOVABLES, S.A. (GRE) from the Index, due to the trading exclusion of all the Company's shares from the MAB and their simultaneous admission to listing on the Stock Exchanges, as well as their inclusion in the Spanish Stock Exchange Interconnection System (SIBE) on December, 16th, 2019, the Committee has decided to substitute the said stock in the IBEX MAB® 15 Index which will thus be composed of 15 stocks again:
