As part of the merger by absorption of certain governing companies of the SIX Group trading venues in Spain, formalized on December 31, 2025, Bolsas y Mercados Españoles Sistemas de Negociación, S.A. has been absorbed by "BME Markets & Exchanges, S.A.U.", formerly known as Sociedad Rectora de la Bolsa de Valores de Madrid, S.A.U.
