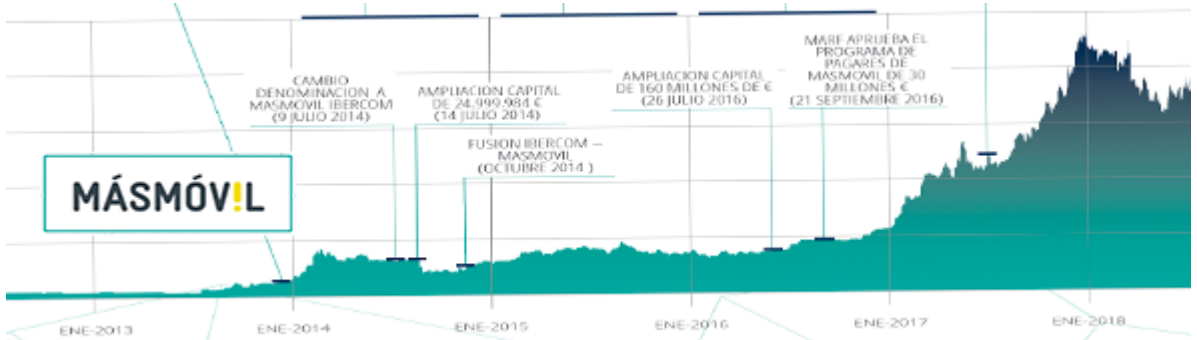

MasMovil: from the Alternative Equity Market (MAB) to the IBEX 35

The Advisory Committee of the Ibex Indexes agreed to the listing of MASMOVIL on the Spain's principal stock exchange, IBEX35, at its first annual meeting on June 13.

MasMovil has been incorporated into the Spanish Stock Exchange's Reference Index, the IBEX 35, only two years after its switch from being publicly traded on the Alternative Stock Market to the Stock Exchange.

MasMovil joined the Alternative Stock Market in 2012 with a capitalization of € 13 million, and went public on the Stock Exchange on July 14, 2017, with a capitalization of more than € 1,200 million. In less than two years from its switch from MAB to the Stock Exchange, MasMovil has doubled its capitalization by reaching € 2,700 million today.

Since its establishment in 2006, the company has gone from being a start-up to being the fourth telecommunications operator in Spain, which is a successful business story in the Spanish Stock Exchange history. As the CEO of the MasMovil Group, Meinrad Spenger, stated: "Our incorporation into the IBEX 35 represents the recognition and consolidation of an industrial project which has been leading the growth of the telecommunications market in Spain for the past two years, and our story in the capital markets is already a successful example of the excellent performance of the Spanish Stock Exchange, where a start-up managed itself to be listed on the IBEX 35, thanks to the support of the Spanish capital markets.
