

MAB KEY INDICATORS. APRIL 2019



Good first quarter 2019 balance

The first quarter of 2019 shows positive figures for the MAB summarized as follows:

The **Ibex MAB 15** has risen by 16.6%. 11 out of the 15 MAB entities belonging to this index have achieved a revalorization during this term.

Trading volume (shares and effective) has almost doubled in comparison with the same period of 2018.

During this first quarter, 5 companies have been incorporated and more than 306 million euro have been raised through capital increases.

The abovementioned figures reinforce the good dynamic of the MAB, consolidating itself as an alternative source of financing.



Barcelona successfully welcomes the Biotech Investor's Day

On 20 March took place in the Barcelona Stock Exchange an investor forum organized by BME with the collaboration of the Spanish Association of Biocompanies (ASEBIO) focused on companies operating in the healthcare/biotech sector. The event was attended by 5 MAB companies (AB-Biotics, Pangaea, ADL Bionatur, Atrys Health, MedcomTech), 3 Spanish Stock Exchange companies (Oryzon Genomics, PharmaMar and Laboratorio Reig Jofre) and 15 investors, which scheduled 41 one-to-one meetings.



Pre-Market Environment participates in the "Startup Olé" event

On 26, 27 and 28 March took place in Salamanca the "Startup Olé" event, one of the main technological-entrepreneurial events in Europe attended by more than 850 innovative start-ups and SMEs with more than 250 investors.

Jesús González, Managing Director, and Álvaro Castro, Director of Markets, participated in several presentations introducing the Pre-Market Environment initiative, which offers a networking and training programme make for start-ups and SMEs aspiring to raising funding through stock exchange markets as an instrument.
