The MAB in figures 2019 (January – November)

The *Ibex MAB 15* and *Ibex MAB All Share* indices closed on November 30 with an annual revaluation of 48% and 23% respectively.

EUR 320 million traded during this period, 60% more compared with the amount traded previous year in the same period.

EUR 1,528 million raised through 77 capital increases.

In addition, during November three new companies have been listed: **Advero Properties Socimi S.A.** (within the REIT segment), **IT Consultant Izertis S.A.** and **Holaluz-Clidom, S.A.** With these new companies, the MAB totals 122 issuers. <u>MORE +</u>



Holaluz and Izertis celebrate the traditional MAB's bell ringing

On November 29th, **Holaluz** celebrated its listing with a valuation of €160 million. The listing has been executed through a mixed operation combining a capital increase, amounting €30 million, with an IPO, carried out by its main shareholders, facilitating therefore, a partial disinvestment from Axon ICT III venture capital fund. **Holaluz**' vision is to connect people with energy that is 100% renewable.

Izertis, on the same week, reached a remarkable market cap of more than 50 million after a booming starting session, which shows the interest of many investors on this technological consultant. <u>MORE +</u>
