- More liquidity: 368.7 million shares have been negotiated with an effective of €810 million (80% more than in 2019).
- More than €428 million have been raised through 71 transactions.
- 9 new companies were listed on BME Growth.
- **BME Growth** capitalization reached €15,920 million in 2020 (5.16% higher than in 2019).

BME to work for its Issuers so that they meet regulatory obligations imposed by SRDII Directive

BME, through IBERCLEAR, will implement during 2021 a service to automate the voting management process at the General Meetings of BME' Issuers, **including those listed on BME Growth**, based on SRDII Directive.

Through this service, management of voting instructions will be centralized in IBERCLEAR, in a neutral and secure manner, facilitating the processes of reconciliation, accounting and confirmation of the vote exercised by the shareholder.
