# BME Growth as an inorganic growth tool: ATRYS successfully completes the acquisition of ASPY and multiplies its size

This new success case illustrates one of the main advantages for companies to list on **BME Growth**: the flexibility of growing inorganically through M&A transactions and being able to pay partially the amount in own shares as they have an objective valuation granted by the market.

With this acquisition, which involves the exclusion of **ASPY**'s shares from trading on **BME Growth**, **ATRYS** reaches a capitalization of € 650 million, approximately, and will now have more than 2,000 employees.
