Smallest and most technological companies grow from BME Growth

BME Growth is an effective finance provider for companies whose size, normally, prevents them from accessing diversified funding sources. If there is one aspect that makes the difference between **ibex Growth Market 15** index (composed by companies with the highest volume) and other indexes, it has been the unbalancing effect of growth values, especially technology, in its composition.

In total, 15 companies listed on **BME Growth** can be classified as a *tech* company accumulating an average profit of more than 230% since their listing.
