#### BME GROWTH in 2021: a year of records and success

The companies listed on BME Growth have been able to adapt and grow in a year that has still been conditioned by the pandemic. The following figures support this good performance:

- **More liquidity**: The turnover amounts to more than €934 million (15% more than in 2020).
- More financing: €960 million have been raised through 80 corporate transactions.
- More companies: 16 new companies were listed in 2021.
- **Greater capitalization**: BME Growth capitalization reached €19,083 million (20% higher than in 2020).
