Quarterly figures in BME Growth with record of funding

The figures for the third quarter of 2022 show a favourable performance in terms of value, financing and liquidity for **BME Growth** companies.

In fact, **more than 820 million € have been obtained through 74 corporate transactions** (7% more than the same period in 2021) and the trading volume has reached € 557 million.

The eleven Catalonia-based companies (excluding REITs) listed on **BME Growth** achieved a combined market capitalization of 871 million \in at the end of September (3.3 times higher than four years ago)



BME Growth's REITs as key players in revitalizing the real estate sector due to their investments

The real estate investment vehicles listed on **BME Growth** closed acquisitions worth 439 million € in the first nine months of the year. In fact, the amount from January to September 2022 already exceeds by almost 75 million € the total investment made by those **BME Growth REITs** throughout 2021.

representing 18% of the total capitalization of growth companies listed on this market.

Over the last five years, the turnover of these Catalonia-based companies has registered a compound annual growth rate of 46.9% and their workforce has grown from 734 to 2,375 employees, more than three times as much.
