Since its incorporation to **BME Growth** in July 2021, **EiDF** has multiplied its metrics and value, reaching a capitalisation of approximately 1,000 million euro. With this growth, the renewable energy company agreed, at its last shareholders meeting, to initiate the procedures to apply for listing on the Stock Exchange.

BME Growth regulation to align with the Securities Market Law and ESMA

Among other things, the modifications made, which entered into force on July 22, published in Circular 2/2022, are adapted to the new Spanish Securities Market Law on the maximum capitalization threshold for companies incorporated to **BME Growth** (from 500 to 1,000 million euro) and, at the same time, strengthen transparency by improving some aspects related to pro forma financial information being, therefore, aligned with the ESMA standards.
