KPIs of BME Growth in 2022: keeps up the pace of financing and adds 15 new companies.

The companies listed on BME Growth have been able to adapt and grow in 2022 despite the complex context. The following figures support this good performance:

- **Liquidity:** The amount of cash traded exceeds €797 million.
- **Financing:** More than €878 million have been raised through 93 corporate transactions.
- **More companies:** 15 new companies were incorporated.
- **Higher capitalization:** BME Growth capitalization reached €20,686 million.

BME Growth companies to meet with international investors in Frankfurt

For another year, **BME Growth** has invited several of its listed companies to participate in the “*Frankfurt European Midcap Event*”, which will be celebrated on **9 February**. Participating in events like this helps boost the international visibility of **BME Growth** companies by meeting with international investors specialized in small and middle capitalization companies.

BME's Pre-Market Environment (EpM) continues to grow, adding new success stories

9 companies have been incorporated in 2022 to this open training, coaching, and networking programme for those companies seeking financing through the capital markets, in which 47 memberships are currently participating (23 companies and 24 partners).

As last year, two companies from the EpM leaped into BME Growth this year. **Enerside Energy** and **Energy Solar Tech**, both operating in the renewable energy sector.

BME Growth's REITs as key players in revitalizing the real estate sector due to their investments Fourth

The real estate investment vehicles listed on BME Growth closed acquisitions worth €600 million in 2022, 64% more than the previous year.

In fact, the amount invested in 2022 exceeds the investments carried out in the two previous years affected by the pandemic.
